

Advance Reservation T&Cs

1. These advance reservation terms and conditions ("**Advance Reservation T&Cs**") are applicable to all customers who have travelled on a booking with Mariner International Travel (UK) Limited (the "**Company**") within the 30 days prior to making an additional booking with the Company (an "**Eligible Booking**").
2. These Advance Reservation T&Cs are only applicable for any direct bookings which are made with the Company.
3. These Advance Reservation T&Cs are supplemental to the Company's booking conditions (as amended from time-to-time) which can be found at [UK-Yachts-Booking-Conditions-Dec-2024.pdf](#) (the "**Booking Terms**"). The Booking Terms are incorporated into these Advance Reservation T&Cs and shall apply to any booking made under these Advance Reservation T&Cs. In the event of any conflict between the Advance Reservation T&Cs and the Booking Terms, these Advance Reservation T&Cs shall prevail.
4. All passengers who travelled on the Eligible Booking and are named on the Booking Confirmation (as defined in the Booking Terms) shall be permitted to make a booking under these Advance Reservation T&Cs (an "**Additional Booking**").
5. Following the completion of your Eligible Booking with the Company, you shall have the option to make an Additional Booking with the Company (with either its Sunsail or The Moorings brand) under these Advance Reservation T&Cs. Any Additional Booking(s) must be made within 30 days following your return from the Eligible Booking.
6. The Additional Booking must depart no sooner than 280 days following the date that the Additional Booking is made. For all departures which are made within (and including) 279 days of the booking date for the Additional booking then the standard Booking Terms shall apply in full (and these Advance Reservation T&Cs shall not apply).
7. In the event that you decide to make an Additional Booking with the Company under these Advance Reservation T&Cs, the payment terms for that Additional Booking shall be as follows:

	Amount payable
Date that the Additional Booking is made	0% deposit
14 days after the date that the Additional Booking is made	20% deposit of the total booking amount
60 days after the date that the Additional Booking is made	30% deposit of the total booking amount
180 days before the departure date of the Additional Booking	Entire balance outstanding of the total booking amount

8. Irrespective of when the Additional Booking is made, the entire amount payable for your booking must be received by no later than 180 days prior to the departure date of the Additional Booking.
9. Any Additional Booking which is made under these Advance Reservation T&Cs may be cancelled without paying any cancellation penalties, provided that notification of the cancellation is received within 14 days following the date that the Additional Booking is placed. For any cancellations or amendments to your booking which are made on, or after, the 14th day after your Additional Booking was placed then the cancellation and amendment terms as set out in the Booking Terms shall apply.
10. The Company reserves the right to cancel, amend or otherwise change these Advance Reservation T&Cs at any time without further notice.
11. Any Additional Booking which is made under these Advance Reservation T&Cs shall be governed by English Law, and the jurisdiction of the English Courts. You may however choose the law and jurisdiction of Scotland or Northern Ireland if you live there and wish to do so.
